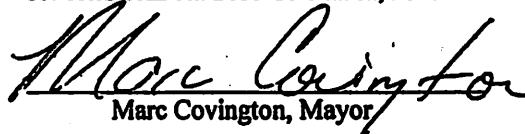

CITY COUNCIL – REGULAR SESSION
March 9, 2020 - 6:00 P.M.**

The meeting was called to order at 6:00 p.m. by Mayor Covington. The invocation was given by Mr. John Adams. All present participated in the Pledge of Allegiance.

Roll Call: Those Council Members present were: Ms. Mary Jo Popma, Mr. John Adams, Mr. Eugene Brown, Mr. Billy Morrow and Mr. Richard Lattier.

Approval of the Previous Minutes:

Mr. John Adams made a motion to approve the February 10, 2020 minutes, and Ms. Mary Jo Popma seconded the motion. Vote was unanimous.

Ms. Mary Jo Popma made a motion to approve the Special Meeting minutes of February 17, 2020, and John Adams seconded the motion. Vote was unanimous.

Open Discussion: None.

Agenda Item One, Vote on Hiring Office Personnel:
