1. MUST be a United States Citizen 2. MUST be at least 18 years of age or older on the commencement of the term filled at the election 3. MUST be a registered voter of the City of East Mountain. 4. (MAYOR) MUST have resided continuously in the state for twelve (12) months prior to filing deadline and twelve (12) months in the city prior to election day. (Alderman/Alderwomen) MUST have resided continuously in the state for twelve (12) months and six (6) months in the city (ward) prior to filing deadline. (Texas Elec. Code, Section 141.001(a); Brown v. Patterson, 609 SW 2nd 287) 5. MUST NOT have been finally convicted of a felony (unless pardoned or otherwise released from the resulting disabilities. 6. MUST NOT be under an adjudication of mental incompetence. 7. MUST satisfy any other requirement prescribed by law for the office	Applications for a place on the ballot for the May 3, 2025 Election will be accepted starting Wednesday January 15, 2025 during regular business hours, Monday thru Thursday 8am-4:30pm and Friday 8am-1:30pm The last day to file for a place on the ballot is Friday, February 14, 2025
