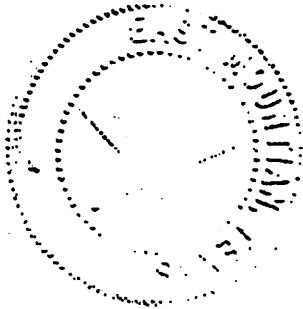



The City opened the public hearing for input on the proposed budget for October 1, 2021 – September 30, 2022 for all city departments. There were no members of the public present. No comments were made.



Agenda Item Two, Adjourn




