

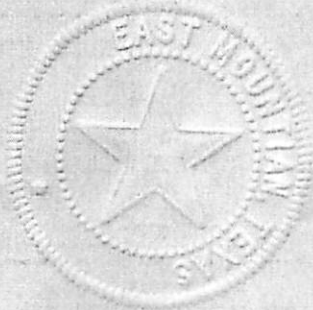



Agenda Item Three, Adjourn:


Mr. John Adams made a motion to Adjourn. Mr. Richard Lattier seconded. The vote was unanimous.
